1. OLD BUSINESS – Kathleen Grim

A. No corrections or additions to the November 2018 minutes, a motion was made and accepted.

B. Eve Gurbacki resigned from the Board of Directors and there was a discussion to find a new chair.

C. Received a thank you letter from Library for payment of Artists and Illustrators magazine

D. Discussed the October/November HAAA events (Christ Church Annville, Center Stage). The church even went

well and all submissions for Center Stage were submitted.

E. Clarification of decision to increase hanging fees was presented as \$5 for 1 - 3 pieces and \$10 for 4 - 6 pieces. The

change applies to all HAAA sponsored shows.

F. Discussed moving forward with the "Hope Springs Farm" plein air demonstration event. Kathleen to follow-up. G. David Pringle, Nick Elsener, and Kathleen Grim will meet to review updater and administrator web functions. An

online post event report form is being developed.

2. NEW BUSINESS A. PRESIDENT – Kathleen Grim

HAAA commission. Credit cards can also be accepted on the HAAA website. Individual artists who currently accept credit card payments and are at the show, may use their processing equipment. But the organization will not be accepting credit card payments at shows at this time.

2. Explanation of Executive Committee to replace BOD email vote as defined in the bylaws. Draft 6 of the bylaw revisions was approved by the BOD and will be posted on the website for member review. Membership vote will take place in early 2019.

3. Discussed possibility of raising dues due to the need to offset costs.

Individual membership dues will be \$25 in 2019, and increase to \$30 in 2020. Family membership will increase to \$40 in 2019 and no change in 2020, and student membership will continue to remain at \$10.00. Wendy Keller made a motion and Lori Lute-Beahm seconded the motion. Discussed the commission on sales at HAAA sponsored shows to increase from 15% to 20% in 2019. Hanging fees for HAAA sponsored shows will be \$5 for 1 - 3 pieces and \$10 for 4 - 6 pieces in 2019.

1. Discussed the use of credit card purchases at shows. (Having customers use credit cards instead of cash). Some of the issues discussed

were who will be working the desk and run the credit cards through the system, training volunteers, deciding who is in charge of the money, and the artist would still have to pay

Susan Gephart made a motion to increase commission and Marcia Leister second the motion

- 4. Discussed approval of Draft 6 of new bylaws; it will be posted on the website for member review.
 (Includes revisions). PANO recommendations keep it simple for emergency services and establish an Executive committee that sits a President, Vice President, and two or three other members of the Board. It should be flexible. Nick Elsener made a motion and Lori Lute-Beahm seconded the motion for approval that Draft 6 can be uploaded to the HAAA website.
- 5. Discussed post show status report consisting of data that will be used and uploaded to website. (How

many artists are participating in shows, etc., which will be used for future planning).

- 5. Discussed holiday party planning Cathy Griffith On Tuesday, December 11, 2018, the Board will be meeting at noon and decorating immediately afterwards. At 6:00 p.m., there will be a dinner party (sign up sheet will be provided).
- 6. Discussed the Hershey Derry Historical Society capital campaign. They introduced a \$3,500.00 fund raising initiative for landscaping the garden area in the rear of the

building. Purchase of a 4 x 8 corporate

recognition brick is \$250.00. Currently, HAAA pays an advance \$50.00 deposit to hold the dates for all HAAA meetings and classes. We have lost our deposit when a class has been cancelled and may need to review this policy. However, considering the HDTHS capital campaign, this may not be the right time to consider negotiation and new rental agreement. Discussed how HAA could help with the fund raising event:

- Possibly holding a show to benefit HDTHS

-Asking for donations, pass the hat during a meeting.

-Make a good faith donation in order to continue to receive our discounted rent.

Mary Lott suggested a \$100 donation and state that we look forward to many more years with them. Deb Reitbauer made a motion and Nick Elsener seconded motion.
